Vision

Invtron DAO revolutionizes venture funding by democratizing investment opportunities, empowering both startups and investors through a blockchain-powered, community-driven platform.

Problem

Startups face significant challenges obtaining funding from traditional avenues due to bureaucracy, competitive gatekeeping, and limited access.

Investors struggle with barriers to accessing quality early-stage investments, dealing with fraud, inadequate due diligence, and limited protection.

Invtron DAO Solution

Invtron DAO provides a decentralized investment ecosystem:

- **Democratized Access:** Everyone with INV tokens can participate in early-stage investment.
- **Crowd Due Diligence:** Community-elected experts (Endorsers) conduct due diligence, enhancing transparency and reducing risk.
- **One-Time Investment, Multiple Opportunities:** Investors buy INV tokens once, automatically participating in diverse, community-approved projects.
- **Blockchain Automation:** Smart contracts ensure secure, transparent governance, voting, and fund allocation.
- **Transparency and Accountability:** All actions, including proposal evaluations and funding distributions, are transparently recorded on the blockchain.

Technical Architecture

- **On-Chain Layer:** ERC-20 smart contracts manage token issuance, voting, and funding distributions.
- **Application Layer:** User-friendly web-based DApp interface for proposal submission, voting, and monitoring.
- **Security Measures:** Thorough audits and wallet-integrated authentication ensure robust security and trust.

Governance Structure

- **Token Holders:** Ultimate decision-makers voting on funding and governance.
- **Endorsers:** Community-elected experts who perform due diligence.

- **E-CEO:** A legally accountable executive responsible for operational execution and regulatory compliance.
- **Voting System:** Weighted voting based on token holdings, incentivized by a unique Proof of Due Diligence (PoDD) reward mechanism.

Tokenomics

- **INV Token:** Utility and governance token, ERC-20 standard.
- **Dual-Token Model:** Combines INV token for governance and a stable-value token for investment stability.
- **Token Supply:** 1 billion INV tokens.

Token Allocation

- Public Sale: 24%
- Team & Partners: 25%
- Marketing: 10%
- Private, Seed, and Strategic Rounds: 24%
- Advisors: 5%
- Liquidity: 7%
- Pre-seed: 5%

Use of Funds

- Marketing & Community: 30%
- Operational Expenses: 25%
- DAO Team & Founders: 20%
- Research & Development: 10%
- Legal & Regulatory: 10%
- Reserve & Contingency: 5%

Investment Process

1. **Submission:** Startups submit proposals.
2. **Due Diligence:** Endorsers analyze proposals rigorously.
3. **E-CEO Approval:** Finalizes proposals for voting.
4. **Community Vote:** Token holders democratically vote.
5. **Funding Execution:** Approved projects receive stablecoin funding.
6. **Monitoring:** Community and endorsers track progress.
7. **Outcome:** Success yields returns shared among investors; tokens may be burned to increase value.

- **August 2025:** Token Distribution and Exchange Listings.

- **September 2025:** DAO Platform Launch.
- **Q4 2025:** First Community Investment Vote.
